4-H FEEDER PROGRAM

The Monte Vista Coop is proud to support our local youth through the 4-H Feeder Program. The program includes:

- **5% Savings** on qualifying purchases during the project year.
- **Eligible items:** feed, supplies, and animal health products.
- **Who can enroll:** 4-H members with a parent, guardian, or grandparent who is a Monte Vista Cooperative member.
- **Apply by:** June 1
- **Season dates:** Accounts are active from the date open and close September 30 of the current year.
- **Reapply each year** to participate in the next season.
- **How it works:** enroll, then shop using your account.
- **Win 2 bags of feed:** 4-H Feeder Program Members may submit a video for a chance to win 2 FREE bags of feed.
 - The video must include footage of the member describing why they are passionate about 4-H and what their plans are to further their education. The more creative the better!
 - Videos must be 2 - 5 minutes in length, but must not exceed 5 minutes.
 - Submit videos to mvcads@mvcoop.com by July 15.
 - Please include contact information.
 - One winner will be selected.

3. I understand in order to comply with the program, I must feed my animal Coop feed purchased through the Monte Vista Coop. **The feed sold under this program must be fed only to livestock carried in the 4H or FFA record book.**
4. **This account can only be used to purchase the following items: FEED _____ TACK _____ ANIMAL HEALTH PRODUCTS _____.** Each item **MUST** be initialed by Registered Youth Feeder Participant.
5. **I shall follow the payment policy as outlined. *Payment Policy:* The Coop will finance your feed purchases with a 30-day credit account in good standing or a letter to the Fair Board stating that upon the sale of livestock your check will list Monte Vista Coop as payee with participant. Please complete and sign the attached credit agreement.** Cash transactions are also acceptable for the program. The Monte Vista Coop may choose to endorse, with you and your parents or legal guardian, the Colorado U.C.C.-1 form. This becomes a legal document and will be recorded in the appropriate office of your county residence. By signing this form, the Monte Vista Coop becomes a secured party of the livestock. Should a participant, for any reason, abandon the 4H or FFA project, the amount owed becomes due immediately. Otherwise, the account is due and payable 30 days following the County Fair. Failure to comply with this policy will result in the Coop taking legal action for collection of the account.

Variance of this agreement is subject to management’s approval.

Sign-up deadline will be the weigh-in date for each project type and will not be accepted after June 1, 2026.
